

MACOMB COUNTY HUMAN SERVICES COORDINATING BODY ANNUAL WORKING AGENDA 2018

A. EXECUTIVE COUNCIL INITIATIVES

NEW GOALS

1. To have the HSCB explore a co-sponsored countywide Summit on childhood trauma in Macomb County in 2019, in partnership with the Michigan ACE Initiative and Easter Seals. Lead: Easter Seals
2. Support community efforts related to the epidemic of opioid deaths in Macomb County, including a potential Affiliated Collaborative relationship with Operation Rx. Lead: MCOSA
3. Consider the development of a County dashboard (a performance measurement that monitors performance trends in several key areas) of local statistics on select health and human service areas to better position agencies to apply for grants and track performance. Lead: Macomb Community Action
4. Explore an Affiliated Collaborative relationship with the new Active Cultural Togetherness (ACT) group as it works toward its vision of a Macomb County environment where all the individuals and groups live, work, and recreate harmoniously with all others, and participate fully, equally, and equitably in all institutions and aspects of Macomb County life and with the assurance that all HSCB projects are culturally competent. Lead: HSCB Executive Council
5. Assess how financial empowerment services offered by the public partners can be more effective and accessible. Lead: Department of Health and Community Services

CONTINUATION GOALS

1. Continue to support the Safe and Together Macomb Implementation Committee as it begins its implementation phase, working on projects described in the Macomb County Domestic Violence Prevention Committee Final Report and Recommendations approved by the Macomb HSCB Executive Council on May 2, 2017. Lead: Inter-Agency Initiatives Steering Committee
2. Continue to implement the new Portal of Service project and work through the system of care issues involved in this project. Lead: Department of Veteran's Services

B. STATE/FEDERAL INITIATIVES

NEW GOAL

1. Investigate the issues surrounding human trafficking in Macomb County for possible cross-agency action. **Lead: DHHS**

CONTINUATION GOALS

1. Continue to coordinate how Martha T. Berry Medical Care Facility, Macomb County Community Mental Health and Senior Services can work together to facilitate and integrate services for seniors with issues of mental health. **Lead: Martha T. Berry Medical Care Facility**
2. Continue to maintain awareness of state and federal initiatives related to health and human services fiscal, policy and/or quality of care changes that may have impact for the collaborative partners of the HSCB. **Lead: HSCB Executive Council**
3. Seek information on the status of the State's Prosperity Regions as it affects health and human services in Macomb County. **Lead: HSCB Executive Council**

C. LOCAL INITIATIVES

NEW GOAL

1. Assist in the expansion of a Red Carpet Registration project using Macomb County veteran volunteers to assist other veterans registering for services at the Dingel Medical Center in Detroit. **Lead: Department of Veteran Services**

CONTINUATION GOALS

1. Continue to work collaboratively with Great Start Macomb as they implement the goals in or being considered for their Strategic Plan in those areas that are HSCB-related and those goals in the HSCB Annual Working Agenda that are Great Start-related. **Lead: HSCB Executive Council and Great Start Macomb**
2. Based on the results of the 2016 MSU survey and its 2017 addendum, MSUE will bring to the HSCB Executive Council table relevant areas that require local collaboration for consideration. To operationalize that effort, MSUE will share annual programming information as a way to explore collaborative efforts with other members of the HSCB Executive Council. **Lead: Macomb MSU Extension**
