### **Financial Services Subcommittee formed**

Financial services are the focus of a new subcommittee established by the Macomb County Human Services Coordinating Body (HSCB). The Subcommittee will work on the following activities and goals:

Identify and assess service gaps and service opportunities to strengthen the level of financial empowerment services in specific geographic areas of Macomb and among specific client populations.

**Develop a collaborative plan** that assesses and prioritizes ways to promote financial empowerment services.

Increase the number of staff who provide financial empowerment services in the county and the number certified by a nationally-recognized accreditation agency such as AFCPE® or CESP<sup>TM</sup> (for professionals working with individual with disabilities).

Examine how to make financial empowerment services accessible and effective.

Identify barriers to financial security for individuals/families.

The Department of Health and Community Services has taken the overall lead agency responsibility for this goal area. The Department's Director Rhonda Powell, has designated two county agency staff to cochair this Subcommittee: Robert Weber from MSU Extension and Mary Frontiero from Macomb Community Action.

### **MATRIX** launched

MATRIX (Macomb's Access to Resource Information Xpress), a computer-based resource referral system, is now available at kiosks around the County.

The MATRIX program offers individuals and families the opportunity to identify their health and human service needs and connects them with services

MATRIX users first indicate their agreement to an inter-agency release of information, supply personal contact information and indicate their preferred mode of communication from the referral agency: U.S. mail, e-mail or telephone call.

Individuals then complete an online questionnaire to indicate their unique situation (i.e., senior citizen, veteran, etc.) and their need/s (utility assistance, food, etc.). Once completed, the information is e-mailed to the participating HSCB member health and human service agencies.

The MATRIX questionnaire is available in English, Spanish, Arabic, Bengali, and has the capacity for persons with visual impairments to use the Job Access with Speech for the Visually Impaired (JAWS) screen reader. JAWS was developed for computer users whose vision loss prevents them from seeing screen content or navigating with a mouse.

# **Safe & Together Trainings**

Since April, 2018 the HSCB Safe and Together Implementation
Committee co-sponsored a series of trainings with the Prosecuting
Attorney's office. The trainings introduced the Safe and Together model and provide supervisory and policy ideas, tools and strategies for immediate implementation at Macomb organizations.

Eighty (80) HSCB member agency staff attended trainings in April and June. Another training is scheduled on October 4, 2018.

Responses on the evaluation forms to the question "What was the most valuable part of the training?" elicited the following responses:

"Learning techniques and tools to assess my client's strengths, and to use my client's strengths in hearings, investigations and pleadings."

"Learning to recognize and address the barriers survivors face."

"I learned the importance of looking at and record the pattern, to document the domestic violence in detail."

"Learning to remove the "whys" and how to be more aware that domestic violence comes in many forms."

"Engaging the perpetrator as a father."
